

Dutch Ministry of Health Visit to Wales



On 16 – 18 October, representatives from the Dutch Ministry of Health, Welfare and Sport (VWS) and the Dutch National Institute for Public Health and the Environment (RIVM) joined Public Health Wales, Welsh Government health leaders and a representative for the Office of the Future Generations Commissioner for a collaborative and learning exchange.

Sumina Azam, National Director for Policy and International Health, said: "It was a huge privilege to welcome delegates from RIVM and the Netherlands Ministry of Health. We found we had much in common, such as ongoing work on climate change, environmental health, health impact assessment and futures.

We had the opportunity to reflect and share learning with each other on our public health challenges and our work to address these." There was agreement on the role of public consultation in policy-making and a shared commitment to fostering community involvement in health initiatives.

Next Steps

Participants agreed that identifying opportunities for collaborative research and policy action in a few areas would be of mutual benefit and were committed to deepening future joint working.

Tropical Health and Education Trust (THET) becomes Global Health Partnerships

As of 6 November 2024, THET has a new name: Global Health Partnerships. The clear, modern name better reflects the focus of their work – which remains the same – working globally in partnerships to improve the quality and affordability of health care in lower- and middle-income countries.

The development of their 2022-2027 Strategic Plan sharpened the focus on evolving language and identity in light of ongoing decolonisation debates – whilst their work has always promoted mutually beneficial partnerships led by locally determined priorities, they recognised that the name was increasingly out of step with the work they were doing on the ground. They were also hit hard by the reductions in UK aid in 2021, meaning the need to attract new funding sources going forward. A clear, modern name that says 'what they do on the tin' is key to this.

Health Protection Lead Nurse joins the Mpox response in Kenya



A specialist Health Protection Lead Nurse, who was inspired to work overseas thanks to her parents, is travelling to Kenya to support the outbreak of Mpox.

Amanda Daniel, the Infection Prevention and Control (IP&C) Lead Nurse Specialist for the Community HARP team, has been deployed with the World Health Organisation (WHO) and Global Outbreak Alert and Response Network (GOARN) as a consultant to support the outbreak of Mpox in Kenya. Amanda will be based in Nairobi for two months as part of her reservist role with the UK Public Health Rapid Support Team (UK-PHRST).

The UK-PHRST is a key international partner in epidemic disease response. It partners with low- and-middle income countries (LMICS) to respond to infectious disease outbreaks before they develop into global health emergencies. The UK-PHRST has expertise in epidemiology, microbiology, infection prevention and control (IPC), social science, risk communication, mental health and psychosocial support.

On her deployment, Amanda said: "Outbreaks are the new normal and we need to work collaboratively and globally to try and contain infection before it spreads.

"Learning in LMICs is always bi-directional, it is important to understand cultural differences so we can apply them in writing policy and guidelines. We can also gain knowledge of how to be resourceful and make better use of limited resources and consider sustainability."

What is Mpox?

Mpox (previously known as monkeypox) is a rare infection most commonly found in parts of central and east Africa. The risk of catching it in the UK is low. Mpox is transmitted from person to person and also from infected rodents (such as rats, mice and squirrels).

Symptoms take between 5 and 21 days to appear and include: high temperature (fever), headache, muscle aches and backache.

There is no current proven treatment for Mpox, but it usually goes away on its own.

A Visit to the Land of the Rising Sun

IHAG (International Health Activity Group) member Diana De, a nurse educator from the School of Healthcare Sciences, Cardiff University, undertook a scholarly visit to the Institute of Sciences, Tokyo (formerly known as Tokyo Medical and Dental University).

This transnational collaboration was forged upon both university's delivering global health modules promoting public health to student nurses.

Diana's visit took place the end of November 2024 and was sponsored by the Great Britain Sasakawa Foundation. Partnering also with the University of Waikato, New Zealand, Cardiff University and Institute of Sciences, Tokyo, an international collaborative online (COIL) activity in Spring 2024.

COILs considered are unique pedagogical approach that looks past traditional didactic ways of teaching. As the project had gained ethical approval, co-authored quantitative findings were able to be presented by Diana at the international Nurse Education Today and Nurse Education in Practice Conference, (NET/NEP 2024), Singapore coincided with her trip to Japan. The qualitative data collected from the mixed methods study are presently being analysed.



Diana's first quest lecture drew upon her involvement with civic mission and public engagement with Cardiff University. This is where health, wealth and wellbeing of communities are put foremost. Diana's talk stimulated attendees to think more inclusively about how they teach in the Japanese context and to consider changing student and population demographics more. By highlighting risks and the importance of health professionals being competent to assess various disease/aetiology in different skin tones, she challenged attendees to instigate new way of working.

On return to the UK, Diana was immensely proud to be the 2024 winner of the Cardiff University excellence in Civic Mission and Public Engagement Award.

Marie Brousseau-Navarro's exchange visit to Finland



In early October 2024, Marie Brousseau-Navarro (Deputy Commissioner and Director of Health at the Office of the Future Generations Commissioner for Wales) and Sumina Azam (National Director of Policy and International Health, WHO Collaborating Centre on Investment for Health & Well-being at Public Health Wales) took part in a 3-day high level exchange visit to Helinski (Finland).

The purpose of the visit was for Finland to learn from Wales about the Well-being of Future Generations (Wales) Act 2015 and from the work in Wales on a well-being economy model to inform their reflections as they set to deepen their own well-being economy framework.

Sumina and Marie met with officials from THL (PHW's equivalent in Finland) to talk about their work and their approaches to food, public health data, learning from their recent merger of social and health local services in Finland, how the Economy of Well-being approach can promote health and well-being and financing of health and social services. They took part in workshops organised by THL.

They also met with representatives of the Government, in particular General Secretary of Ministry for Social Affairs and Health Veli-Mikko Niemi and with Eeva Furman, Chief Specialist, Prime Minister's Office, Government Strategy Department, Government Policy Unit who wanted to know more about our work in Wales.

Marie had the honour of meeting with Pekka Puska, former Director of THL and the creator of the world-renowned North Karelia Project.

Marie and Sumina agreed to continue to work together and have further exchanges with Finland around foresight, learning more about healthcare reforms and the merger of services and health economics.
